The student remains the responsibility of the resident school district until the effective start date at the nonresident school.</li> <li>• The parent/guardian will be notified by email (or postal mail if an email is not provided) of acceptance and the effective start date or rejection.</li> <li>• If the request is rejected, the notification will include the reason for the denial and steps to appeal the decision.</li> <li>• If a district does not respond to a request within 45 days of the request, the request is treated as a denial and the parent/guardian can appeal.</li> <li>• Under the Choice law, the nonresident school district becomes responsible for all matters related to the education of the student (basic education, special education, home/hospital services, truancy, CEDARS reporting, administration of state educational assessments, etc.). Note: Information will be provided in written format; no information will be released over the phone.</li> </ul> <p>The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232(g); 34 CFR Part 99) is a Federal law that protects the privacy of student education records. The law applies to all schools that receive funds under an applicable program of the U.S. Department of Education.</p> <p>FERPA gives parents certain rights with respect to their children's education records. These rights transfer to the student when he or she reaches the age of 18 or attends a school beyond the high school level. Students to whom the rights have transferred are "eligible students."</p> <p>Parents or eligible students have the right to inspect and review the student's education records maintained by the school. Schools are not required to provide copies of records unless, for reasons such as great distance, it is impossible for parents or eligible students to review the records. Schools may charge a fee for copies. Generally, schools must have written permission from the parent or eligible student in order to release any information from a student's education record.</p>
