ISOLATION AND RESTRAINT OF STUDENTS WITH IEPs AND SECTION 504 PLANS

It is the policy of the Stanwood-Camano School District Board of Directors that the district maintains a safe learning environment while treating all students with dignity and respect. **All Students, with an including those with Individualized Education Program (IEP), an Aversive Intervention Plan (AIP), or a and plans developed under Section 504 of the Rehabilitation Act of 1973 4 (Section 504 plan), will therefore remain free from unreasonable isolation, restraint, or restraint devices ("isolation and restraint") during school-sponsored instruction and activities.**

The use of isolation and restraint of these students will generally be avoided and will not be used as a form will never be used as a form of discipline or punishment. The district recognizes, however, that isolation and restraint are necessary at times to preserve the safety of students and school staff. The district therefore authorizes these actions under limited **set of** circumstances. This policy and its accompanying procedures set forth the statutory definitions and authorized uses of isolation and restraint as well as incident review, **reporting, documentation, procedures and requirements for reporting** and parent/guardian notification **procedures and requirements.**

The district will provide parents or / guardians of students with an IEP or Section 504 plan a copy of the district's **isolation and Rrestraint** policy **when the IEP or Section 504 plan is created and will include parent/guardian notification procedures in the student's IEP. At the time such programs or plans are created. All IEPs will include the district's procedures for notifying parents/guardians of the use of isolation or restraint.**
