Attached you will find a Letter of Agreement between the Stanwood-Camano School District (the District) and the Public School Employees of Stanwood-Camano (PSE). This agreement is in addition to contract language in the current Collective Bargaining Agreement between the District and PSE.

The Letter of Agreement provides incentive pay to prospective bus drivers who complete required Commercial Drivers' License and district related training and who subsequently drive for the district for thirty (30) days.

14	In order to incentivize recruitment of Bus Drivers, the District and Public School Employees of Stanwood-
15	Camano, agree to pay new Bus Driver Trainees a stipend equivalent to seventy (70) hours at the
16	Washington State minimum wage rate. Drivers coming to the SCSD from other districts will earn
17	incentive pay equivalent to forty (40) hours at the Washington State minimum wage rate.

19	These stipends will be payable to new Bus Driver employees or substitutes after thirty (30) days of driving
20	for the Stanwood-Camano School District. For the purposes of this agreement, the definition of a day is
21	either an AM and PM route, or an AM or PM route and an extracurricular trip.

23	Half of the incentive pay will be paid in the first possible payroll following five (5) days of driving.

27	This Letter of Agreement shall become effective upon the signature of all parties involved and will be in effect
28	until August 31, 2023 and shall be attached to the 2020-2023 Collective Bargaining Agreement.
