SUBJECT: Approval of SMS Window Replacement Project #0162 Bid Award

DATE: January 17, 2023

TYPE: Action Needed

The 2019-2022 Facilities and Technology Levy included funds to continue replacement of exterior windows at Stanwood Middle School. Phase I of this work was the replacement of windows on the south facade of the Administration/West classroom wing of the school, completed in 2017. Continuing work will replace the single pane aluminum windows in the original portion of the building with insulated fiberglass windows.

Base Bid work on this project includes window replacement on the west, south, and east elevations of the building. There are two bid alternates included in the package. Alternate #1 adds classroom window replacement on the north elevation, and Alternate #2 includes washing and painting the building. The District received four (4) responsive bids on the project. The apparent low bidder withdrew their bid without penalty within the timeframe allowed for bidder error. The next apparent low responsive bid was provided by Tatley-Grund, Inc. of Seattle, Washington for the base bid amount of \$797,659.00. The bid amounts for Alternate #1 and Alternate #2 are \$97,309.00 and \$59,850.00 respectively.

The original estimate for this work was \$875,000. The budget for this project can accommodate acceptance of the combined Base Bid and Alternate #1, for a total amount of \$894,968.00. As part of this project, the District anticipates it will apply for and receive a Commercial Incentive from Cascade Natural Gas of approximately \$20,000.

The Architect has reviewed the documentation provided by the contractor and recommends that the contract be awarded to Tatley-Grund, Inc. as indicated in the attached letter.

We recommend the board <u>move to approve contract award</u> for the Stanwood Middle School Window Replacement Project #0162 to Tatley-Grund, Inc. of Seattle, Washington for the combined Base Bid and Alternate #1 amount of \$894,968.00.
