During this meeting, the board will need to provide time for a public hearing related to the proposed changes in director district boundaries and converting to one at-large position and four director districts. The public should be encouraged to comment on the proposed changes. Unless public comments result in concerns the board would wish to address in the redistricting plan, plan adoption would occur during the November 4 board meeting. I have attached a copy of the redistricting schedule in case you have any questions.

Again, changing board member district boundaries has no effect on school attendance areas.

Recommendation:

We recommend the board **move to conduct a public hearing, for the purposes of soliciting comment from the community regarding the board's redistricting plan, during the October 21, 2008, regular board meeting.**
