On November 5, 2013, voters approved the School Facilities and Technology levy. One of the technology projects funded by this special levy includes software for student learning.

Beginning, in 2014, our students began using IXL Learning as a resource to increase learning opportunities for mathematics. Teachers and parents have used IXL as a way to supplement learning and provide additional practice for students. During the 2017-2018 school year, the increase of the availability of Chromebooks resulted in a heavy increase of IXL learning. We also began using the language arts portion of their software in support of grammar instruction and support of EL student learning.

This past year, over 3,300 of our students used IXL. 21 percent of the use was in their home environments where they answered nearly 7 million questions and practiced over 224,000 skills.

Considering the widespread use of the software (particularly during distance learning) and its benefit to students, we are requesting the renewal of this contract. The terms of the agreement involve 50% of the total being due in the first year and 25% each of the remaining two years. See attached quote for specific details.

Recommendation:

We recommend the board <u>move to approve the contract of \$99,226</u> for the <u>purchase of IXL Learning licenses</u> for a three year term spanning the 2021-2022, 2022-2023, and 2023-2024 school years.
